



Among the evidence collected by JPFO is this letter from the congressional law librarian to Senator Thomas Dodd, which was introduced as evidence before the congressional subcommittee investigating juvenile delinquency in 1968—hearings that led in part to the enactment of GCA '68. Exhibit No. 62 shows unequivocably that the late Senator Thomas J. Dodd had in his possession, prior to the drafting of GCA '68, a copy, in German, of the original text of the Nazi Weapons Law of 1938.
